





Project Types and EU-Financing Rates

Small-scale projects

- Budget max 20 000 Euro/country
- 6-12 months

Regular Projects

• Max 3 years

Financing Rate

- 65% EU-funding for Swedish and Finnish partners
- 50% Norwegian Interreg-funding for Norwegian partners






